THE GARBAGE TRUCK PASSES ON **MONDAYS** AND **THURSDAYS**. PLEASE PUT YOUR CAN TO THE ROAD THE NIGHT BEFORE TO ENSURE YOU DON'T MISS IT. ALSO, PLEASE PULL YOUR CAN FROM THE ROAD THE SAME DAY THAT IT IS EMPTIED. IF MAINTENANCE HAS TO MOVE YOUR GARBAGE CAN, YOU WILL BE CHARGED \$25.



It is a lease violation to have someone living at your unit who is not on the lease. If you want a significant other to live with you, do it the honest way and bring them in to be screened. If not, you are risking eviction!



Rent is due January 12<sup>th</sup> which is the eighth working day of the month. If you do not pay by January 12<sup>th</sup>, a \$10 late fee will be applied. If you signed a contract, your rent is due January 15<sup>th</sup>, but a late fee is still applied after the 12<sup>th</sup>. The absolute last day to pay the rent is January 20<sup>th</sup>.

IF YOU PLAN ON MOVING OUT, YOU HAVE TO GIVE A TWO WEEK NOTICE AND SIGN A NOTICE TO VACATE OR YOU FORFEIT YOUR ENTIRE SECURITY DEPOSIT. IF YOU MOVE OUT BEFORE THE 15<sup>TH</sup> OF THE MONTH, WE WILL PRORATE YOUR RENT. IF YOU MOVE OUT AFTER THE 15<sup>TH</sup> OF THE MONTH, YOU ARE RESPONSIBLE FOR THE ENTIRE MONTHS RENT. ALSO, SECURITY DEPOSITS ARE NOT FOR UNPAID RENT.

SECURITY DEPOSITS ARE FOR CLEANING, DAMAGES TO THE UNIT, TRASH REMOVAL, EXTERMINATION, ETC.

electricity), please call the office and listen to the

answering machine to get the phone number to the maintenance staff on call. You must then hang up and call that number. If it is not an emergency, please wait to call in the work order when we are open.

Please do not wait until the end of the day to call in work orders, especially something like a stop up or leaking water heater! You do not have to be home for maintenance to complete the work order. If you wait until the end of the day, you can be charged \$25 for the work order.
