AS PER YOUR LEASE, ALL MOTOR VEHICLES MUST BE **PROPERLY LICENSED AND** TAGGED AND IN RUNNING CONDITION WITH FULLY **INFLATED TIRES. VEHICLES** THAT ARE NOT IN RUNNING CONDITION WILL BE TOWED AT RESIDENT'S EXPENSE. **NO JUNK VEHICLES, BOATS OR LARGE TRUCKS ARE ALLOWED. RESIDENTS MUST OBTAIN BHA APPROVAL TO PERFORM** ANY VEHICLE MAINTENANCE ACTIVITIES. YOU MUST ALSO OBTAIN A PARKING STICKER FROM THE BHA OFFICE TO PUT ON THE WINDSHIELD.



Rent is due MAY 12<sup>th</sup> which is the eighth working day of the month. If you do not pay by MAY 12<sup>th</sup>, a \$10 late fee will be applied. If you signed a contract, your rent is due MAY 15<sup>TH</sup> but a late fee is still applied after the 12<sup>th</sup>. The

absolute last day to pay the rent is **May 20<sup>th</sup>**.



Summer is right around the corner, so we want to remind you that plastic or inflatable swimming pools for the kiddos or adults

are **NOT** allowed on BHA property for liability

reasons. Children also are **NOT** allowed to play in the water hose or have a slipn-slide because of water costs. If we find out you have used the water for this purpose, you will be charged for the excess water costs. Inflatables

such as fun jumps or water slides also **CANNOT** be used on BHA property. If you see any of these activities taking place, please report it to the office.



MONDAY, MAY 26<sup>TH</sup> If you have a maintenance emergency (gas, water, electricity), please call the office and chose option 4 to talk to the maintenance staff on call.

## OFFICE DROP BOX

There is a drop box located on the left side of the main office door for you to leave rent, check stubs, recertification packets, etc. when the office is not open.



## **Re-enrollment** for Next School Year

If you need a printout from the office, to prove proof of residency, to enroll or reenroll your child/children for the next year school year, you need to CALL THE OFFICE IN ADVANCE to request a copy.



The monthly spraying for April will be done on Thursday, May 15<sup>th</sup> and Friday, May 16th. You do not have to be home, but if you are home and refuse to allow them inside, you will be charged. Also, remember that 3 housekeeping notices results in eviction. THE MOST IMPORTANT PART OF ELIMINATING ROACHES IS TO SWEEP OUT OR VACUUM DEAD ROACHES FROM THE CABINETS, DRAWERS AND ALL APPLIANCES AT LEAST ONCE A WEEK!





IF YOU WANT A PET, YOU MUST COME TO THE OFFICE TO FILL OUT A PET CONTRACT AND PAY A \$100 NON-REFUNDABLE PET DEPOSIT **BEFORE** GETTING A PET. THE DOG OR CAT MUST BE UNDER 25 LBS FULL GROWN.
