Guest-Alvin Francois request to be removed off of the MCPD and Agency Barred List.

Mr. Robinson informed the board that he had received a request from Mr. Alvin Francois and his sister Marla Lavine requesting to be removed from the barred listing. Mr. Francois had been placed on the list in 2002. Mr. Robinson stated that he didn't know why he was placed on the list, but he knew why he was arrested for the last matter that is the family concern now. In the month of August Mr. Francois contacted me stating that he wanted to come pay the rent for one of our current residents. I told him that he could come bring the rent, but he had to leave the

development as soon as he complete the transaction. He did pay the rent, but before he could leave the development, someone called the police department and he was arrested. I contacted Assistant Chief Augman about the arrest informing her that I had authorized Mr. Francois to come pay the rent. She stated that she would inform Judge Stansberry about the matter. The bond was reduced and he was released until his court date in October. The board members asked why was he still on the list being the barring taking place so long ago. Mr. Griffin informed them that the Police Department and the agency have a policy that once placed on the list, the individual must write a request to the director then request to be placed on the board meeting agenda before a decision could be made for removal. Mr. Francois finally took the proper measure to appear before the board. Attorney Duffy stated that he would need a copy of the original C-1 to speak with the City Attorney concerning moving forward with the removal of Mr. Francois from the list. The board members went into discussion and concluded that they would allow for Mr. Francois name to be removed from the list.
